#### Why do we collect your information?

#### What information do we hold and where does it come from?

- Your family, spouse and partner details
- Your contact details, including postal address, email address and telephone numbers
- Any contact Cardiff Consultancy Services has had with you such as appointments, emergency appointments, emails etc
- Notes and reports about your health
- Details about your treatment and care, including medication
- Relevant information from referring agencies.

#### How do we keep your information confidential?

We will hold your information on computers and paper and we use a combination of sound working practices and technology to ensure that your information is kept confidential and secure.
